
# Rules Regarding preparation of Assignment File.

- ➤ It is mandatory to submit the said assignment in hard copy within stipulated time.
- ➤ Student should prepare only one file having spiral binding which includes the assignments of all the 4 subjects.
- Student should prepare his/her assignment file in his/her own handwriting only.
- > Student can prepare his/her file in Hindi or English.
- ➤ There is no limit of minimum and maximum pages but norms of law exams held by CCS University should be adhered to as far as possible. The question should be completely answered.
- ➤ Student shall prepare their assignment file on both side on A4 size Sheet (with or without lining page).
- > Student shall only use black or blue colour ball/ gel pen for writing the assignment file. In any case, other colour pens for writing shall not be acceptable.
- ➤ Cover page must be in the printed form, which contains name of the college, name of students, his/her father's name (Performa is enclosed with this).
- ➤ Students should submit their assignment file for checking within the prescribed date i.e., 13<sup>th</sup> Sep'25, beyond this date no file shall be checked or entertained on any ground whatsoever.
